Board of Directors I Call for Nominations January 2024

The ALS Society of Canada (ALS Canada) is working to change what it means to live with amyotrophic lateral sclerosis (ALS), an unrelenting and currently terminal disease. Our vision is a world free of ALS and our mission is to improve the lives of Canadians affected by ALS through advancing research, care, advocacy, and information.

Founded in 1977, the ALS Society of Canada is a registered charity that receives no core government funding – our work is powered by generous donors who share our vision for a future without ALS. ALS Canada has been accredited by Imagine Canada for best practices that help strengthen governance and operations.

The governance structure of ALS Canada includes a Board of Directors (Board) that provides leadership to the organization by defining its strategic direction, stewarding its resources, providing oversight and ensuring accountability to the community and to the public. The Board is made up of up of 15 Directors based on a comprehensive skills matrix. The Board and organization are supported by the Scientific & Medical Advisory Council, Community Services Advisory Council and the Advocacy Committee.

The Governance Committee is seeking recommendations for potential Directors to serve a two-year term. A Director's term may be renewed up to two times at the discretion of the Board for a maximum of six consecutive years, considering the collective skill requirements and interests of the Director. From the recommendations received, the Governance Committee will put forward a slate of Directors to be considered by the Board.

The slate will be constructed to ensure the Board, as a group, is diverse and has a balanced mix of backgrounds and skills from across Canada. For this round of recruitment there are two open positions, the Board is seeking individuals with key skills and experience in the areas of finance (CPA designation), government relations/advocacy, corporate governance, legal and risk management.

It is expected, Board Members will have the time and experience to make a significant impact on the long-term performance of ALS Canada and are passionate about making a difference in the lives of people living with ALS today and in the future, while we work towards a world free of ALS.

Please note that no individual under the age of 18, nor someone found to be mentally incompetent, who has the status of a bankrupt, or who is an 'ineligible individual', as defined in the *Income Tax Act* is eligible to serve as a Director (section 5.03).

Governance Committee to conduct initial vetting of long list.

Step 2: February 5

Initial interview – CEO to meet with potential candidates – introduction, request of application and CV/bio and two references familiar with the candidate's experience.

Governance Committee to identify short list.

Step 3: February 26

Secondary interview – Governance Committee to connect with potential candidates.

Governance Committee to put forward proposed Board Members for Board consideration.

Step 4: April 4

Invitation extended to new Board Members.

Step 5: April 15

New Board Members will be invited to participate in onboarding sessions to gain an overview of the organization and review of expectations and logistics.
